



THE FOLLOWING ARE THE OFFICIAL RULES AND REGULATIONS OF AMERICAS MOST BEAUTIFUL PAGEANTS. CONTESTANTS MUST READ AND ADHERE TO THE FOLLOWING RULES AND REGULATIONS IN ORDER TO PARTICIPATE IN THE PROGRAM.

TO BE ELIGIBLE AS A CONTESTANT:

- CONTESTANT MUST BE AT LEAST 8 YEARS OF AGE BY COMPETITION YEAR. 30 DAY GRACE PERIOD ALLOWED FOR AGE DIVISIONS CUT OFF DATES. CONTESTANTS MAY CHOOSE TO BUMP UP OR DOWN A DIVISION IF THEIR BIRTHDATE IS WITHIN 30 DAYS OF JAN 1ST.
- CONTESTANT MUST BE OF GOOD HEALTH AND MORAL CHARACTER.
- CONTESTANT MUST NOT HAVE BEEN CONVICTED OF A FELONY CRIME.
- A CONTESTANT COULD BE SELECTED TO PARTICIPATE AS A DELEGATE "AT LARGE" IF THERE IS NO COMPETITION IN HER STATE.
- CONTESTANT WILL BE SUBJECT TO A REGISTRATION FEE AND AN AD PAGE FEE. FURTHERMORE CONTESTANT UNDERSTANDS ALL FEES PAID ARE NON REFUNDABLE. NO EXCEPTIONS
- MINORS MUST NEVER HAVE, NOR WILL SHE DURING HER REIGN, POSE FOR ANY PHOTOGRAPHY, VIDEO, OR ANY MEDIA ASSOCIATED WITH ANY NUDITY OR PORNOGRAPHY. NOR HAS SHE EVER OR IS SHE PRESENTLY INVOLVED IN ANY FORM OF EMPLOYMENT WHICH INVOLVES PARTIAL OR COMPLETE NUDITY.
- CONTESTANT AGREES ALL DECISIONS OF JUDGES AT THE LOCAL, STATE AND NATIONAL LEVELS ARE FINAL AND IRREVOCABLE, AND THAT SHE WILL ABIDE BY ALL REGULATIONS AT THE STATE AND NATIONAL COMPETITIONS. FURTHERMORE, ANY CONTESTANT AND OR FAMILY MEMBER OR GUEST, SHOWING LESS THAN SPORTSMAN LIKE BEHAVIOR AT THE PAGEANT WILL LEAD TO DISQUALIFICATION OF THE CONTESTANT WITH NO REFUND UNDER THESE CIRCUMSTANCES.
- CONTESTANT WILL PERMIT AMERICAS MOST BEAUTIFUL PAGEANTS AND THEIR LICENSEES THE RIGHT TO USE CONTESTANT'S PHOTOGRAPH FOR PUBLICITY PURPOSES IN CONNECTION WITH ALL COMPETITIONS.
- CONTESTANT WILL PERMIT AMERICAS MOST BEAUTIFUL PAGEANTS AND THEIR LICENSEES TO TELEVISION LIVE, OR BY THE USE OF FILM, VIDEO OR OTHER MEDIA, USE ANY PORTION OR ALL OF THE COMPETITION.
- CONTESTANT, IF SELECTED, AGREES TO ATTEND THE NATIONAL COMPETITION AS THE STATE REPRESENTATIVE AND ABIDE BY ALL THE RULES AND REGULATIONS REQUIRED BY SAME OR FORFEIT TITLE. IF CONTESTANT RELINQUISHES, FOR ANY REASON, ANY TITLE GIVEN HER, ALL PRIZES MUST BE RETURNED IN FULL, AND IN CONDITION RECEIVED OR WILL FINANCIALLY REIMBURSE THE PAGEANT AND SPONSORS FOR ANY SERVICES OR GIFTS RECEIVED.
- CONTESTANT FURTHER UNDERSTANDS THAT IF SELECTED A WINNER IN HER COMPETITION, THAT FOR ONE YEAR HER PROFESSIONAL AFFAIRS, AS SAID WINNER WILL BE UNDER THE SOLE MANAGEMENT OF AMERICAS MOST BEAUTIFUL PAGEANT AND/OR THEIR LICENSEES AND THAT SHE WILL NOT GIVE ANY WRITTEN OR ORAL ENDORSEMENTS COMMERCIALY WITHOUT THE EXPRESSED PERMISSION OF SAID SAME.
- CONTESTANT ACKNOWLEDGES THAT ALL FEES PAID ARE FINAL. NO REFUNDS. CONTESTANT MAY PUSH HER ENTRY BACK ONE YEAR IF UNABLE TO COMPETE. BUT WILL BE SUBJECT TO A FEE FOR A NEW SASH.
- CONTESTANT ACKNOWLEDGES THAT ALL RIGHTS FOR ANY APPEARANCES, ENDORSEMENTS, SPEAKING ENGAGEMENTS, ACTING ROLES, ETC. RESULTING FROM WINNING OR BEING A CONTESTANT IN ANY REGIONAL, STATE OR NATIONAL COMPETITION AFFILIATED WITH AMERICAS MOST BEAUTIFUL, SHALL BELONG EXCLUSIVELY TO SAME.
- THESE RULES AND REGULATIONS ARE SUBJECT TO MODIFICATION, AS NEEDED, WITHOUT PRIOR NOTICE.
- AMERICAS MOST BEAUTIFUL PAGEANT RESERVES THE RIGHT TO MAKE SAID MODIFICATIONS AT ITS SOLE DISCRETION.
